

Minutes of the 14th IQAC meeting of Godavari Institute of Engineering & Technology (A) was scheduled at 10.30 am on 21st November, 2020.

Following points were discussed:

A) Action taken report on the proposals of 14th IQAC meeting

- 15.1 University Innovation Fellows – Stanford University – Status
- i. Fourth batch of 4 students shortlisted for University Innovation Fellows (UIF) programme of the Stanford University, U.S.A.
 - ii. Efforts are on to involve more students to take part in the unique program launched jointly by Stanford University, USA, Google Inc., USA, and APSSDC, AP - India.
 - iii. Students have presented their ideas which will definitely improve teaching – learning eco system in the campus.
 - iv. Faculty appreciated their ideas and encouraged them to implement the same with the guidance of mentors.
- 15.2 Consultancy Works – Status
- i. Department of Management Studies and Department of Civil Engineering found to be active in consultation activities.
 - ii. Other departments should also take necessary steps to boost consultancy activities in their respective areas.
- 15.3 MSME – Business Incubation Center - Status
- i. The **proposal submitted** by our institute for recognition as Host Institute (HI) for implementation of the scheme "Support for Entrepreneurial and Managerial Development of MSMEs through Incubator" **has been Approved.**
 - ii. Members appreciated the initiation and felt that it would certainly improve Innovation and Incubation outlook among all stake holders.
- 15.4 Implementation of UGC's Paramarsh scheme – Progress
- i. Members reviewed status of UGC's Paramarsh scheme and discussed about new manuals of NAAC which are in force from January, 2020.
- 15.5 Participation in NIRF – Status

 - ii. Members opined that the application be submitted by 15.02.2020.


- 15.8 MSME – Business Incubation Center :
