

#### CLAUSE 1 CO-OPERATION



## CLAUSE 2 SCOPE OF THE MoU


#### CLAUSE 4 VALIDITY

Any act on the part of **Training Partner** or **M/s BULLOGIX SOFTWARE SOLUTIONS PRIVATE LIMITED**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.


